

The small print in advance - General information

Costs

For the contract transfer of individual products, a fee of 50 EUR per product incl. VAT (19 % VAT applies to Germany, depending on the VAT rate of your country the actual price may vary).

Time of transfer

Of course, we will try to carry out the transfer of the contract on the date you specify. Please note that the date may be delayed due to internal processing times.

A retroactive contract handover is not possible. Invoices that have already been issued therefore cannot be changed retroactively.

Billing

The billing periods of the contracts managed under the customer account are not changed by the transfer of the contract. Thus, depending on the current billing periods, your products will be billed on the next respective date. You can find out the respective billing periods from the previous contract party.

Username (KIS login)

If you want to change your username, please note the following specifications respectively restrictions:

- letters and numbers only
- no special characters, spaces or umlauts
- at least 5 characters
- at least one letter
- no e-mail address

If the desired username is already taken, Host Europe will assign you another one. If you do not want a new username, simply leave the field blank.

Unique (main) e-mail address of your master data

The main email address is the email address that is linked to your customer account and to which all contract-related notifications (invoices, maintenance work, etc.) are sent by default. This e-mail address is also the only one used for the "forgot password" function.

The main e-mail address cannot be used for multiple customer accounts.

If the e-mail address specified in the form is already used under another customer account, the contract transfer cannot be made.

Signatures and data for companies of individuals (without registration/non trading company)

For companies of individuals (without registration/non trading company) all shareholders of the previous and new contract partner must sign the handover.

For the new contract partner all shareholder full names are required.

Persons entitled to information
